- V. Financial Report

- Rochelle Friend from the HDESD reported that PBCCS is doing well with expenditures. We are currently operating under the projected budget.
- Friend shared that the state economic forecast is positive for future budget planning.
- Piehl asked Friend a financial review question: Are checks and balances currently in place?

Friend - Yes, there are four staff members handling PBCCS' finances at the HDESD.

### **Budget Priorities**

- 4% COLA is projected. After districts have set their budgets, PBCCS will review regional trends.
- Increasing the insurance contribution is a priority in planning.
- Discussion:

Piehl- Increasing staffing capacity to help in younger classes.

O'Shea - With recent hires, staffing is at the same capacity as last year.

O'Shea - Classified Salary Schedule, make sure it is competitive with other comparable jobs.

Friend - PBCCS is unique because they don't belong to the union. PBCCS could consider offering hiring or longevity bonuses to be more competitive.

### VII. Administrative Report

- A. ODE/OHA Update Masks to become optional on Marsh 31, 2022. Waiting for the revisions on Ready Schools Safe Learners guidance from ODE to assist in planning. PBCCS will be working with the CCSD to be in compliance, and update the required health and safety plan.
- B. Exercise-A-Thon This fundraiser was amazing this year. Donations totaled over \$30,000. Great support from the community and very good student participation.
- C. Enrollment 2022-23 PBCCS has extended the open enrollment date to April 1st with hopes CCSD will allow PBCCS to update the enrollment procedures.
- D. School Happenings Teachers are participating in professional development and place based planning on Feb 18 and March 4. Trips to the Cove Palisades and Smith Rock are being scheduled with transportation and community partners.

## VIII. Board Comments

Piehl - What is the status of the Mod? Waiting for county inspections.

Urell - The school is continuing down a road that is not working, in regards to mask requirements. Believes PBCCS should abide by guidelines and not take focus away from learning.

Dennis - Thanked parents for showing up and showing support for family and parent choice. From a parent point of view, she is tired of asking her kids to do something she doesn't believe in.

Peterson - Shared a few examples of students struggling with masking from a school field trip and also seeing a student at the grocery store.

Has been approached about the open Board position, how can people get an application? Board application is available on the school website.

Holliday - Agrees with what everyone here has said. Wonders how the board navigates the situation.
